General Rules: See the essay tips for guidelines on formatting the References list. Also refer to the References example for proper format.

- Use author initials for first and middle names
- Use & between multiple authors (not "and")
- Capitalize the first word in a title and subtitle and proper nouns. All other words are in small letters.

Three to Seven Authors

List by last names and initials; commas separate author names, while the last author name is preceded again by ampersand.

More Than Seven Authors

List by last names and initials; commas separate author names. After the sixth author's name, use an ellipses in place of the author names. Then provide the final author name. There should be no more than seven names.

- Date of publication
- Date of access
- URL
