Final Exam: Mini TED Talk

TED is a non-profit organization that posts videos of people presenting ideas on fascinating topics. The presentations are done on stage in front of hundreds of people, and they are usually around 15-20 minutes long. The most important requirement for a TED Talk is that the idea (topic) is worth spreading to lots of people. Your final exam will be in the form of a presentation, you will prepare a mini TED Talk. It is the same style as a TED Talk, but shorter. This assignment is worth 20% of your final grade.

Topic:

You can talk about **whatever you want** as long as it is "an idea worth spreading". You can even do a topic from a past assignment. Get your topic approved by your teacher beforehand.

Time limit: 8-10 minutes

Other requirements:

- 1. Have a story
- 2. Get an audience member to speak
- 3. Hand gestures
- 4. Business casual clothes

Part 2: Thinking

Submit an audience analysis. Talk about the audience's

- 1. Attitude towards your topic
- 2. Understanding of your topic
- 3. Demographics
- 4. Interest level in your topic
- 5. Expectations towards your presentation
- 6. **N**eeds or wants from your presentation
- 7. Customization to make your presentation better for your audience
- 8. Environment of the presentation

Part 3: Communication & Application

In class, you will do your mini TED Talk. Use the advice from lesson 5.2 to improve your charisma and credibility. Use stories, hand gestures, smile, wear business casual, have vocal variety (emphasis).

Overall Expectation:

- 1. Planning Presentations: plan presentations for specific purposes and audiences;
- 2. Delivering Presentations: Communicate orally for a variety of purposes and audiences, using the forms, language, and techniques of effective oral presentations.

Learning Goals:

- 1. Make presentations in a variety of forms for various purposes and audiences
- 2. Use appropriate techniques in both individual and group oral presentations.
